- Display stands must be supplied by the artist for any sculptures which are not floor pieces. Wall-hung sculptures of any kind cannot be displayed.
- Artists must be 18 years of age or older to enter.
- All entries must be priced for sale.
- No Portfolios, please.

The judge and committee members have the right to refuse any work considered objectionable. Space limitations may apply.

ENTRY FEES

\$10.00 each work. Limited to three works.

Bath County Arts Association receives a 30% commission on all sales.
